Materials are provided in one of the conference languages. These materials must be accompanied by an application for participation in the conference. Abstracts containing the results of their own research are accepted for publication. The authors are responsible for the content of the materials in the abstracts. Materials are not subject to additional editing, so they should be carefully prepared.

The material presented should be logically connected, clearly and concisely presented, and have an appropriate structure.

In the process of presenting the material, the scientific style and principles of academic integrity should be followed. All submitted materials will be checked for the absence (presence) of academic plagiarism, fabrication, falsification.

The right to include the materials of the reports in the conference programme remains with the organising committee.

Requirements for conference abstracts

Abstracts of reports with a volume of 3-5 pages in A4 book format are accepted for printing. The text of theses must be typed in Microsoft Word in *.doc or *.docx format

The size of the sheet is A4, the orientation is portrait. Times New Roman font, size 14. Line spacing -1.5. All margins are 2 cm. Paragraph indent -1.25 cm. Text alignment - by width. The name of the file should match the section number and the last name of the first co-author.

Surnames and initials of co-authors (all, no more than three) are written on the right in capital letters; under them - educational institution, city; at intervals - the title of the abstract is printed in capital letters, alignment - in the middle; after an interval - text.

The list of used references, drawn up in accordance with the requirements of DSTU 8302:2015, is given at the end of the abstract. Each item in the list should be referenced in the text (in square brackets, example: [1, p. 12-15]).
